
2022 BUDGET

The 2022 Budget funds programs that support the Strategic Vision's five Priority Pillars established by the Governing Body.



Your PROPERTY TAX

As a Shawnee resident, your property taxes support education, parks and recreation, libraries, as well as the county and state. For each dollar you pay in property taxes, the following entities receive a portion based on the individual mill levy for each.

Calculating Your CITY PROPERTY TAXES

In 2022, the City's property tax rate (or mill levy) used to calculate property taxes is .026004. Below is the formula to calculate your property taxes.

Your Home's Market Value x 11.5% = Your Home's Assess Value Assessed Value x City's Mill Levy Rate (.026004) = What you pay in City Property Taxes

Example: $$311,085 \times 11.5\% = $35,775$

 $$35,775 \times .026004 = 930

The average value of a home in Shawnee is \$311,085. Therefore, the average City property tax (as shown on the tax bill) is \$930 per year or \$77.50 per month. Property Tax bills are available on the Johnson County Treasurer's website at taxbill.jocogov.org.

Sales Tax

For every \$100 in purchases, residents and businesses pay \$9.60 in sales tax. Of this amount, the City receives \$1.63. The remaining \$7.97 goes to the State of Kansas and Johnson County.

Stormwater Utility Fee

Stormwater Utility Fee is used to manage the City's Stormwater System that consists of more than 179 miles of pipe, nearly 10,000 inlets and junction boxes, 100 miles of roadside ditches, and 13 miles of improved channels. The 2022 fee is \$6 per month for each single-family dwelling. Non-residential properties pay a fee based on impervious surface area. 


Budget 2022 HIGHLIGHTS

- Reduction of the mill levy rate of approximately .5 mills to 26.004
- Fire facility improvements at Fire Station 71 at 6501 Quivira and Fire Station 73 at 6805 Hedge Lane Terrace

- Establish a temporary property tax rebate program for low income
- Six new police officer positions approved for the Police Department
- Legal team will move in house to more efficiently consult and advise
- An additional Mental Health Co-Responder to assist the Police Department
- Communications Assistant in the City Manager's Office
- Part-Time Special Populations Programmer in the Parks and Recreation Department
